Dear Editor and Author,

Please find attached is the reviews and suggested edits for the manuscript entitled "Potentials of Mangrove Carbon Species as Conservation Indicators in Jor Bay East Lombok, Indonesia".

This paper could enrich existing information about carbon in mangrove ecosystem, in the context of Lesser Sunda region, particularly in Lombok Island. Nonetheless, the manuscript was very poorly written with many inaccuracies in the language, so that I would suggest to edit as in the attached file. Some concerns include:

1. The previous title is too far from what presented in the paper. I would suggest changing the title as in the attached file.
2. I never heard a mangrove with name *S. casidaris*. Please check again. I think it might be *S. caseolaris*.
3. In Figure 1, Please add an inset map of Indonesia to provide perspective of where Lombok is located (please note that not all readers are familiar with the region). Also, in the Legend, please use English instead of Bahasa.
4. In the Methods, Please describe how many plots were created along with the information

about the size of each plot.

5. In the Methods, later on, I found there is no significant value index, diversity index, and basal area in the Results. If you did such analyses, please add the results, otherwise please remove these from the Methods.

6. In the Results, It is inconsistent when it says only five species of mangrove while in Table 1, there are seven species. Please check again and clarify.

7. In the Results, It seems not make sense regarding the size of diameter which reach 30.5 meter. Please check again whether it should be in cm (if refer to diameter) or if it uses meter perhaps it refers to height?

Some minor issues are detailed in the attached file.
