Reviewer Comment For Author:

1. The authors did not do the cost analysis between the biosensor output with chromatography, and GC-MS outputs, which needs to be included and discussed in detail to justify the current method of determination.
2. Is the biosensor detecting only organophosphate pesticides? Need clarification.
3. What is the maximum limit of concentration up to which this biosensor is detectable? Needs to be addressed.
4. A comparison should be made between the biosensor outputs and other methods of determination.
5. The calibration of the biosensor for the measurement of the concentration of pesticide was missing; it needs to be included with Fig. and explained.
6. How frequently is calibration to be done for the biosensor? Needs to be addressed in detail.
7. How did the authors justify that biosensors produced better results than other methods? Clarification is required (apart from the statistical analysis data).
8. The authors have to explain how to prepare the sample for testing the pesticide availability in soil and plants,

which is missing.

9. If the performance of the biosensor decreased as the day prolonged (Fig. 4), then what is the limitation of the biosensor against the time to measure the pesticide concentration? This needs to be addressed more.

10. What is the manufacturing cost of the biosensor? Information required.

11. The authors have to present a photographic view of the biosensor.

Reviewer Reports:

I recommend a major amendment at this level.

General comments:

The manuscript entitled "Silver-based plasmonic nanoparticles for biosensor organophosphate pesticides using a single film containing acetylcholinesterase/choline oxidase" was reviewed. The work carried out in the manuscript is interesting and aimed at developing a biosensor for organophosphate determination. The innovation and the importance of this work are not clearly highlighted in the abstract, introduction, and conclusions. Please work on this and prove to us why this work is valuable. Please also remove ANY lumped references. Please define each of them separately to avoid inappropriate citations. It is recommended that the authors work with a science editor who is proficient in the Native English language to improve the organization and delivery of some portions of the manuscript. Too many abbreviations are used in the analysis and results. The journal's author guidelines and instructions should be followed in preparing the revised version. Other main remarks that in my opinion needs attention are the following:

Detailed comments:

In the abstract, please add an indication of the achievements from your study that are relevant to the journal's scope. Please be concise - maximum 1-2 lines.

The review of the literature needs more updating with works to have a clear and concise state-of-the-art analysis. This should more clearly show the knowledge gaps identified and link them to the paper's goals. The introduction section is poorly organized. While the general introduction is acceptable, the state-of-the-art review that follows is very difficult to understand and no specific thoughts can be inferred. The major defect of this study is the debate or argument is not clearly stated. You may see these articles and follow in the revised version. The relevant reference may be of interest to the author according to below: <https://doi.org/10.1016/j.chemosphere.2023.138263>; <https://doi.org/10.1038/s41598-023-33095-1>; <https://doi.org/10.1016/j.jclepro.2020.124553>; What are the advantages of using silver-based plasmonic nanoparticles for biosensor detection of organophosphate pesticides? Can the biosensor develop using the single film containing acetylcholinesterase/choline oxidase be used for detecting other types of chemical contaminants?

How does the sensitivity of the biosensor compare to other commonly used detection methods for organophosphate pesticides?

What are the potential applications of this biosensor technology in the field of environmental monitoring?

All the findings of the current work need to be compared and discussed with the results of other researchers finding instead of having a general comparison with other researchers' works. The authors should perform a comparison between the forecasting results. Has the biosensor been tested in real-world settings, and if so, what were the results?

Are there any safety concerns associated with the use of silver-based plasmonic nanoparticles in biosensor technology?

How does the cost of the biosensor compare to other available detection methods for organophosphate pesticides?

How does this biosensor technology contribute to the broader field of biosensing and environmental monitoring?

Please make sure your conclusions section underscores the scientific value-added of your paper, and/or the applicability of your findings/results. Highlights the novelty of your study. In the conclusions, in addition to summarising the actions taken and results, please strengthen the explanation of their significance. It is recommended to use quantitative reasoning compared with appropriate benchmarks, especially those stemming from previous work.
